Windshield Sealant Limited Warranty – Includes No Charge Reapplication Every 6 Months: To ensure your Windshield Product Warranty is performing at its peak level, we will provide no charge reapplication service. The reapplication service will be reapplied when your original protected windshield was replaced or damaged from flying debris (The damaged windshield is not covered by this limited warranty). This limited warranty does not cover repair or replacement of your windshield. Includes No Charge Reapplication Every 6 Months - Simply bring this contract and your vehicle treated with the windshield Product into the dealership and we will retreat with the proprietary Reapplication Formula. You can do this as often as every six months for the term of the warranty.

Exterior Sealant Limited Warranty — Includes No Charge Paintless Dent Repair: We guarantee the treated exterior surface of the Registered Vehicle will retain its high luster and shine from exposures to weather-induced fading, oxidation, hard water etching, bird droppings, tree sap, road salt, road de-icing agents, acid rain, industrial fallout, insect damage including love bugs, chrome water spotting. Includes No Charge Paintless Dent Repair - We guarantee Paintless Dent Repairs of minor dents and dings four inches (4" or less) to exterior vertical and horizontal painted sheet metal body panels of the treated exterior surface of the Registered Vehicle. We have the right to professionally recondition, repair and/or detail any damaged area before repainting any surface. We may attempt to remove any stain by means of professional cleaning or reconditioning before replacing any surface. When repairing, replacing, or repainting the interior or exterior of any Treated Surface, it may not always be possible to exactly match the color and/or texture of the undamaged Treated Surfaces. These discrepancies are not covered, and We are not responsible for such instances. We reserve the right to inspect any damaged portion of the Treated Surface prior to authorizing a remedy. Stains, rips, punctures and burns may be repaired or replaced by the use of inserts in lieu of replacement of the entire surface. 2. In the event there is an odor due to a food or drink stain, warranty coverage is limited to cleaning and reapplication of interior product. 3. Method of Repair of Eligible Dents: The repair of covered dents is limited to the Paintless Dent Repair process, to accessible dents, by a certified Paintless Dent Repair technician who will determine whether the dent can be repaired as covered herein. We/Us/Our and Administrator shall mean Century Automotive Service Corporation, PO BOX 3809, Albuquerque, NM. 87190-3809, 1-888-338-0389, the Warrantor, who is responsible for providing and administering the benefits under this Limited Warranty (unless indicated otherwise in the state specific section of this Agreement). You/Your shall mean the individual or company noted on the Limited Product Warranty Registration Form under Section Registered Owner Information. Registered Vehicle means the vehicle owned by You noted on the Limited Product Warranty Registration Form under Section Registered Vehicle Information, to which the Product was applied.

A. WARRANTY DESCRIPTIONS: We agree, subject to the terms and conditions of this Agreement to the following, if purchased by You and applied to the Registered Vehicle, as indicated on the Limited Product Warranty Registration Form .

Windshield Sealant Limited Warranty – Includes No Charge Reapplication Every 6 Months: To ensure your Windshield Product Warranty is performing at its peak level, we will provide no charge reapplication service. The reapplication service will be reapplied when your original protected windshield was replaced or damaged from flying debris (The damaged windshield is not covered by this limited warranty). This limited warranty does not cover repair or replacement of your windshield. Includes No Charge Reapplication Every 6 Months - Simply bring this contract and your vehicle treated with the windshield Product into the dealership and we will retreat with the proprietary Reapplication Formula. You can do this as often as every six months for the term of the warranty.

Exterior Sealant Limited Warranty — Includes No Charge Paintless Dent Repair: We guarantee the treated exterior surface of the Registered Vehicle will retain its high luster and shine from exposures to weather-induced fading, oxidation, hard water etching, bird droppings, tree sap, road salt, road de-icing agents, acid rain, industrial fallout, insect damage including love bugs, chrome water spotting. Includes No Charge Paintless Dent Repair - We guarantee Paintless Dent Repairs of minor dents and dings four inches (4" or less) to exterior vertical and horizontal painted sheet metal body panels of the treated exterior surface of the Registered Vehicle. Provision of service under this Agreement may not be attempted or provided on a particular dent or ding in the event that a paintless dent repair technician determines, in his/her own discretion that the damage cannot be repaired using Paintless Dent Repair. Warranty/Benefit Limits: As long as conditions herein are met and the damage can be repaired through the Paintless Dent Repair process, there are no limitations as to the number of Paintless Dent Repairs you may receive within the term of the Agreement. Subject to the conditions, exclusions and limitations contained herein.

Anti-microbial Interior Sealant Limited Warranty – includes No Charge Rip, Tear & Burn Repair: We guarantee the treated interior surface (Fabric, Vinyl, Leather and Carpet) of the Registered Vehicle to remain free from damage caused by permanent stains, UV exposure, temperature extremes and the interior Treated surfaces are also warranted against odor caused by mold or mildew as a result of food and/or drink. Treatment for odor is limited to cleaning the vehicle and retreating. Includes No Charge Rip, Tear and Burn Protection - We guarantee repairs of burn and puncture repairs with a circumference less than one (1") inch and Tears less than six (6") inches in length. Paint Protective Film 1("PP Film 1") Limited Warranty - Includes Hood, Fender, Mirror & Door Edges: We guarantee the Registered Vehicles paint surface which has been treated with PPF, including repainting, if damaged as described herein, subject to the limitations and exclusions below set forth herein.

Paint Protective Film 2 ("PP Film 2") Limited Warranty - Includes Front Bumper: We guarantee the Registered Vehicles paint surface which has been treated with PPF, including repainting, if damaged as described herein, subject to the limitations and exclusions below set forth herein.

B. TERM OF WARRANTY: Warranty under this Agreement is only valid for the period of time indicated on the Registration Form.

C. REQUIREMENTS AND LIMITATIONS ON CLAIMS: 1. Method of Repair or Replacement for Exterior and Interior Surfaces (excluding dents): The method or repair or replacement is in Our sole discretion. We have the right to professionally recondition, repair and/or detail any damaged area before repainting any surface. We may attempt to remove any stain by means of professional cleaning or reconditioning before replacing any surface. When repairing, replacing, or repainting the interior or exterior of any Treated Surface, it may not always be possible to exactly match the color and/or texture of the undamaged Treated Surfaces. These discrepancies are not covered, and We are not responsible for such instances. We reserve the right to inspect any damaged portion of the Treated Surface prior to authorizing a remedy. Stains, rips, punctures and burns may be repaired or replaced by the use of inserts in lieu of replacement of the entire surface. 2. In the event there is an odor due to a food or drink stain, warranty coverage is limited to cleaning and reapplication of interior product. 3. Method of Repair of Eligible Dents: The repair of covered dents is limited to the Paintless Dent Repair process, to accessible dents, by a certified Paintless Dent Repair technician who will determine whether the dent can be repaired as covered herein. You understand that certain dents, even though treated are not repairable or covered hereunder, for example (a) lack of access to the dent, (b) dents located on bumpers, plastic panels, fiberglass panels, trim, chrome, (c) dents that have been previously repair with body filler and/or repainting, (d) dents larger than four (4") inches in length or diameter, (e) dents that have sharply indented the metal, (f) dents on body lines or defined curves that are not flexible enough to remove dents using the Paintless Dent Repair process,(g) Roof dent repairs that require the removal of sunroofs or mounted electronics or video screens to gain access to the dent. (h)The Selling Dealer/Distributor who provides You with this limited warranty must complete the Registration Form and submit the Registration page to Us along with the proper payment. We reserve the right to reject this registration, without obligation to any party, if it is not fully or accurately completed, or if the Selling Dealer/Distributor fails to pay Us for the products purchased by You, the customer.

D. AGREEMENT:1. This Agreement only covers repairs or replacements authorized by Us. We do not cover any repairs or replacements made by others which We have not authorized. We reserve the right to inspect all damage and claims prior to approval. 2. You must take every reasonable precaution to protect the Registered Vehicle from exposures that could damage the exterior and interior surfaces of the Registered Vehicle from loss or damage. 3. You may contact the Limited Product Warranty Administrator to file a claim by calling 1-888-338-0389. 4. Covered losses will be remedied by reconditioning, detailing, repair or replacement of the covered surface at Our sole discretion. 5. Product(s) have been applied to the Registered Vehicle and cannot be removed. Therefore, this Limited Product Warranty is non-cancellable by either party. 6. Transfer - The original purchaser shall have the right to transfer this Limited Product Warranty to the first subsequent owner of the Registered Vehicle. To continue Warranty coverage, the original purchaser must submit a written request to Century Automotive Service Corporation, PO BOX 3809, Albuquerque, NM. 87190-3809, 1-888-338-0389., within 30 days from the date of sale of the Registered Vehicle. The written request must include the following: Transfer Coverage TO (Name

of First Subsequent Vehicle Owner); Address/City/State/Zip; Phone; Date of Transfer of Ownership; and Vehicle Identification Number along with a transfer fee of \$50.00. 7. Deductible – There is no deductible required to obtain coverage of benefits under this Limited Product Warranty.

E. FILING AND PROCESSING OF CLAIMS: 1. It is Your responsibility to contact the Administrator, Century Automotive Service Corporation, PO BOX 3809, Albuquerque, NM. 87190-3809, 1-888-338-0389 prior to completing any repairs and immediately upon notice of damage. 2. You must contact the Administrator once visible damage has begun. 3. Delay in filing a claim could result in the worsening of the problem because necessary repairs are not made in a timely manner to minimize damage. Failing to report your claim in a timely manner which results in unnecessary damage, could void Your Limited Product Warranty coverage. You may be asked to provide information regarding the damage (including pictures), a copy of Your limited warranty registration form, and/or proof of product purchase, and/or identification. For a claim to be considered, the claim must be filed during the Term indicated on the Registration associated with this limited warranty.

F. LIMITATIONS & EXCLUSIONS: This Limited Product Warranty does not cover and specifically excludes damage caused or resulting from the following:
Exclusions Relating to All Products: (a) Preexisting conditions, loss or damage which occurred prior to the application of the Products, (b) Repairs made to the Registered Vehicle not pre-approved in advance by Us, (c) Claims arising where the product was not applied and installed by an authorized dealer or distributor of The products (d) Failure to properly and reasonably maintain and protect the Registered Vehicle from exterior or interior exposures or damage, (e) Damage caused by acts of God (fire, flood, hail, sand storms, natural casualties), (f) Damage caused by collision, accident or other similar event, (f) Rust or surface rust, (g) Original manufacturer's defect, (h) Neglect, abuse, abnormal use, intentional damage, vandalism or malicious mischief, act which would cause abnormal discoloration or deterioration, (i) Terrorism, acts of war, (j) Commandeering by law enforcement or government agencies, (k) Commercial use of a vehicle, such as, but not limited to, emergency vehicles, police cars, ambulances and trucks rated over one ton, (l) Failure to provide multiple bids if required by the Administrator or photographs of the damage when required by Us, (m) Claims that exceed the maximum dollar amount set forth below in section G, (n) The product application-specific exclusions set forth below, (o) Claims submitted by anyone other than the Registered Owner, (p) Claims relating to the Product where the Limited Product Warranty was not registered with Us or our Administrator. Exterior Sealant Limited Warranty Exclusions – Includes No Charge Paintless Dent Repair: (a) Non-clear coated surfaces, (b) Damage caused by road hazards, (c) Modification or alterations of the original factory finish, (d) Repainted surfaces, (e) After-market pin stripping, (f) Vinyl graphics or decals, (g) Paint chips, scratches or damaged cause by neglect, (h) Rusting of metal. Includes No Charge Paintless Dent Repair (a) Large dents. Large dents may be non-repairable using the Paintless Dent Repair process, (b) Environmental damage. Warranty claim payments made under this limited warranty are limited to not exceed the actual cash value "ACV" of the vehicle as determined by the NADA Official Used Car Guide average trade-in value, at the time the warranty claim payment is made.

WE SHALL NOT BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES REGARDLESS OF THE LEGAL THEORY ASSERTED, INCLUDING WARRANTY, CONTRACT, NEGLIGENCE, OR STRICT LIABILITY. SOME STATES DO ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.
